Committee Reports:

• Roads and Maintenance:

- We continue ditch digging and continue to maintain Alpenwald roadways. Ditch digging looks good.

Use and Design:

- One outstanding application, this has been sent to the Use and Design Committee and waiting for approval.
- No one has yet requested a driveway permit. As a reminder, before starting any driveway work, an application needs to be submitted to Alpenwald for approval.

Legal:

We had one outstanding legal case where we received payment this week.

- We will be moving forward with legal action against 1 long outstanding balance that we have made every attempt to collect and provide payment options to with little success.
- No other outstanding legal matter with members at this time.
- We do have one interesting matter that may require legal assistance. In 2008, a property was acquired by AVI that is located in both the town of Stamford and the town of Readsboro. The deed was not properly recorded with the town of Stamford at the time of this acquisition. Alpenwald does not have the original deed, however, we still have boxes to go through from the 2008 former president and we will continue to look for this. He was the one who signed off on this originally so if we have this document it will be there. We need to figure out how to formerly file that deed so title can be properly transferred as this has subsequently been sold and title needs to be accurately transferred.

New Business:

Appointment of New Board Member:

- Following the last meeting, Linda Tannenbaum resigned from the board. She has worked on the board for the last six years, we appreciate her service and thank her for her time.
- We appointed Mike Cole to complete her term. Welcome Mike to our board. Mike has been a member of our community for several years.
